2. **SARAH² QUEEN** (**WILLIAM¹**), alias “Sally,” was born about 1847 in the Second Election District of Anne Arundel County, Maryland, and died on 9 Oct 1926, at 1320 Carey Street, Baltimore City, Maryland.⁴ She was buried on 12 Oct 1926, at the St. Mark’s Cemetery, in Harmans, Anne Arundel County, Maryland. She married **ALFRED HARRIS** on 7 Jun 1866, at the White Marsh Church, in Collington, Prince George’s County, Maryland.⁵ Ceremony performed by Fr. Charles A. Bague, S.J. Alfred Harris was born on 13 Mar 1834 in Maryland, and died on 16 Dec 1911, in Anne Arundel County, Maryland.⁶

9. **PETER THOMAS³ HARRIS** (SARAH², WILLIAM¹) was the firstborn child of Alfred Harris and Sarah Queen. He was born on 14 Sep 1868 in the Fourth Election District of Anne Arundel County, Maryland, and baptized on 12 Mar 1869, in Collington, Prince George's County at the White Marsh Church. Rachel Burley was his sponsor.¹¹ He died on 15 Mar 1943, in Weverton, Washington County, Maryland, and buried on 18 Mar 1943, at Pleasant Valley Cemetery, in Brunswick, Washington County.¹² Sometime in the late nineteenth century, Peter migrated north to Washington County—near Antietam Creek.¹³ In 1895, he married **CICELY ANN ANDERSON**, daughter of Robert W. Anderson and Caroline A. (nee _____), who was born 30 Nov 1868 in Maryland, and died 14 Feb 1956, in Garretts Mills, Washington County, Maryland.¹⁴
